## Graduate Business School Policies:

- Students must speak to an advisor (via phone, e-mail, or in person) before registering for classes for their first term.
- Students are expected to meet all course *PREREQUISITES* and *COREQUISITES*. A Prerequisite is a course which must be completed prior. A corequisite is a course which may be completed prior or concurrently. Prerequisites and corequisites are enforced by the registration system.
- Students must apply for graduation prior to CENSUS DATE of the last semester.
- A grade of “C” or higher is passing and required for all graduate coursework. A grade of “C” or better is required for all prerequisite coursework. Cumulative GPA must be 3.0 or higher to graduate.
- This Degree Plan contains the current official course requirements and may only be modified by a Graduate Business School employee.

## MS in Taxation Program Prerequisites (9 hours)
